#### 2. Registration

6. Cancellations, cancellation of weeks, and changes:

Any changes or cancellations must be notified in writing to summer@queenscollege.es.

- Before May 15th, bookings can be cancelled, and full payment will be refunded.
- From that moment (May 15th) until June 19th, if the registration is cancelled, the course will be refunded minus a €100 reservation fee. Cancellation is not possible after the 19<sup>th</sup> of June.
- Similarly, as of **June 19th** it will not be possible to request partial cancellation of weeks.

#### 7. Friends

If you wish for your child to be in the same group as another student, you must indicate this on the registration form.

Please note that we cannot guarantee that two (or more) friends will be in the same group. We try our utmost to keep friends together. However, we are required to take into account age differences and group sizes when making these decisions. We will prioritise friend grouping by order of enrolment, and would encourage any interested families to ensure that all friends in a potential friendship group are enrolled as early as possible to avoid disappointment.

#### 9. Changes to the reserve

Families will be notified of groups on the Thursday before each week of the programme. Therefore, if you have any requests regarding group changes, friends, etc. you must apply before 10:00 am on the Thursday prior to each week.

If you would like to extend the timetable (e.g., add dining room) you must provide notification no later than one week in advance.

#### 10. Excursions

The school borders the Bellver Forest and so it forms part of the school's daily life. Therefore, during the summer school, activities can be organised for all Summer Challenge students in the forest.

It is also possible to organise cultural visits, for example to the Joan Miró Foundation, located near the school. Families will always be notified in advance.

#### 11. Lost property

We recommend that children do not bring valuable belongings to the centre. We encourage all children to be responsible for their belongings. In the event of loss, we will do our best to find and return the items. However, the centre is not responsible for their replacement.

Please label all students' belongings with their full name to facilitate return in case of loss.

#### 12. Absences, lateness, and early departures

As far as possible, please try to respect the arrival and departure times. For the sake of organisation, please notify **summer@queenscollege.es** in writing of any absence, lateness or early departure in advance.

We would be grateful if you could consider the timetable of the activities, especially swimming, in order to be able to take advantage of the whole session.

#### 13. Snacks, packed lunch, and allergies in the group

Students should bring their own snack and a bottle of water labelled with their name. The bottle can be refilled throughout the day on site.

Lunch is at 14:00. Please note that students who choose the packed lunch service and bring their own lunch will not be permitted to heat it. The lunch box must be kept in a cool place. It must be clearly labelled with the students' name on the outside.

Due to possible allergic reactions, it is strictly forbidden to bring nuts to school. In addition, in specific cases, you may be notified that an anonymous pupil in your group has an allergy to a particular food and asked to refrain from bringing snacks or meals containing that allergen.

#### 14. Information

In the middle of June, we will contact registered families with further information about the programme: necessary material, timetables, arrival and departure instructions, etc.

#### 15. Behaviour

We expect that, at all times, the parent-school relationship will be smooth and cordial. We are at your disposal to deal with any concerns you may have. Likewise, we will be in touch with you should we feel it necessary.

Students must be attentive, respectful of their classmates, and follow the teacher's instructions. They must also respect school furniture and material. Any damage done voluntarily to property belonging to the school, teachers or pupils will be the responsibility of the parent or legal guardian. In the case of repeated misbehaviour, the school will contact the parent or legal guardian.
